### FOR INDIAN DONORS WHO WISH TO RECEIVE A TAX DEDUCTION donations made within India only (section 80G of the Income Tax Act)

**BY CHECK** to Auroville Unity Fund, Town Hall, 605101 Auroville, Tamil Nadu  
with a note specifying “Donation for Acres for Auroville” and requesting the exemption

**BY CREDIT OR DEBIT CARD** via the Auroville Donation Gateway
